In the Hawiyah-Unayzah Gas Reservoir Storage (HUGRS) Project we selected ARCC again, trusting in its experience, capabilities and expertise in the industry", Managing Director Dong Chan Kim said during the awarding ceremony.

"Again, thank you to Samsung Engineering Co., Ltd.; to Mr. Dong Chan Kim, Mr. John Kim, Jinsu An and Mr. Sung An Choi and to all wonderful people of Samsung and to the selection panel for choosing ARCC as this year's recipient. We are honored and happy in this recognition", Mr. San Miguel added.

In winning this year's Contractor Excellence Award, the selection committee selected ARCC after besting more than 5,000 subcontractors of Samsung Engineering Co., Ltd. worldwide.

ARCC is currently engaged with Samsung Engineering as a sub-contractor for the Structural, Mechanical, Piping, Painting and Insulation Works in HUGRS Project. The contract was awarded to ARCC on July 31, 2020 and is expected to be completed on February 27, 2023. With almost 1,000 workforce now on site, the project is expected to peak (with gradual mobilization of additional 500 manpower) in the succeeding months until first quarter of 2022. As of May 2021, the project has achieved a safety record of 1,346, 840 Man-Hours Without Lost Time Incident.

HUGRS project is located 180km southwest of Dammam and 250km south of Jubail. It was developed to provide the necessary facilities to store surplus sales gas by injecting into the existing well during off-peak season for reproduction back into the Master Gas System to equalize the high demand at peak season, thereby maximizing the plants utilization. It includes a design compression facility for injecting 1500 million standard cubic feet per day (MMSCFD) and a design reproduction facility for reproducing 2000 MMSCFD of sales quality gas.

To support the huge demand of the project, ARCC established a Pipe Spool Fabrication Facility in HUGRS Project Site. It started operation in November 2020 with fabrication capacity of 1,500 Dia-Inch per day per shift and 5 tons of pipe supports per day.

ARCC receives Final Mechanical Completion Certificate

Al Rushaid Construction Co., Ltd. (ARCC), received the Final Mechanical Completion Certificate (MCC) from Saudi Aramco after successfully completing the Replace Pressure Vessels at South Ghawar Project on 08 April 2021 in Al Hassa, Saudi Arabia.

In the Mechanical Completion Certificate, Saudi Aramco certified that the facility has been inspected and that all materials met the applicable Saudi Aramco Standards, and that it is constructed in agreement with pertinent design and engineering specifications. Furthermore, Saudi Aramco also certified that tests have been conducted and witnessed demonstrating that the Project is mechanically completed and ready for commissioning and start-up.

"It is of our great pleasure to share with everyone that the BI-10-01522 or Job Number 2040 also known as Saudi Aramco Replace Pressure Vessels at South Ghawar is finally completed as per the Project Final Mechanical Completion Certificate (MCC) given to us by Saudi Aramco," Project Manager Jay-Ar T. Dacquel said in his announcement. "The final MCC manifested our great work for this challenging yet rewarding project, I would like to thank everyone from our Top Management headed by our General Manager Simon Elmer D. San Miguel for his trust and support, down to our project workers who has contributed to the success of this Project, Mr. Dacquel added.

"I would like to congratulate ARCC Team South Ghawar headed by



Mr. Simon Elmer D. San Miguel said in his congratulatory message. *"This Saudi Aramco Lump Sum Procure Build (LSPB) Project is another feather on our cap and this translate a great deal with our long-time client and partner, once again we gained Saudi Aramco's trust after we commissioned this important project".*

"I salute all the gallant men, for their commitment and making our company proud", the General Manager added.

Part of ARCC's scope is to replace the Sixteen (16) existing non-hydrogen induced cracking (Non-HIC) with the new HIC resistant vessels at Nine (9) Gas Oil Separation Plants (GOSP) of South Ghawar Oil Fields. ARCC is responsible in performing all associated civil, structural, piping, equipment installation and disposal of the retired vessels at Aramco Shedgum Reclamation Area including Electrical & Instrumentation Works, Pre-Commissioning Works and assistance to commissioning.

The challenge to ARCC is to meet the expectation and objective of Saudi Aramco and that is to meet the Crude Program in maintaining Crude Oil Production and Maximum Sustainable Capacity (MSC) Targets for Arab Light (AL) Crude from South Ghawar Oil Fields and improve Plant Safety by the replacement of existing Sixteen (16) non-HIC resistance pressure vessels with HIC resistant one in Uthmaniyah GOSP-4, 7, 8, 11 and 12, Hawiyah GOSP 2, 3 4 and Haradh GOSP – 1.

Aside from accomplishing the Project with a resounding success, the Project received astonishing Project Quality Index (PQI) of 97.89%, with a 0.91% Weld Rejection Rate at Completion for Joint Basis and 0.0246% for Linear Basis. The project also received a remarkable Project Safety Index (PSI) of 97.3% with recorded 2,744,735 Man-Hours Without Lost Time Incident (LTI).

Due to COVID-19 Precautions and Protocol, a simple recognition ceremony was held in Dammam Office Building (DOB), attended by ARCC Executive Manager and Key Aramco Project Management Team where in Saudi Aramco Department Manager Mr. Khalid Zamel Al-Sulaim presented the Plaque of Appreciation to ARCC for distinguished efforts and dedication in achieving the successful completion of BI-101522 (Replace Pressure Vessel at South Ghawar) with the highest standards of Quality & Safety.

Shuqaiq III Seawater Reverse Osmosis Plant 3 Project



In a region with acute water scarcity, demand for desalinated water is being driven by climate change and population growth. Acciona Agua S.A. acquired the services of Al Rushaid Construction Co. Ltd. in building Shuqaiq SWRO Plant 3 capable of producing 450,000 cubic meters of potable water per day serving the cities of Abha and Jizan covering potential population of 2 million inhabitants in the extremely dry region of Saudi Arabia.



The most challenging part of the Reverse Osmosis System is the assembly and the precise alignment of 7,848 units Pressure Vessel into 23 RO Racks which already attains 86.9% progress. Nineteen RO Racks have already been accepted ready for commissioning while the remaining five 2nd Pass RO racks are undergoing final alignment. Commissioning is expected to be completed on 16 July 2021 while the RO PV membranes installation shall commence on 02 to 30 July 2021.



The Project at 86.54% progress as of 05 June 2021, has successfully completed various critical stages like Seawater Chlorination, Dual Media Filter, Waste Water, Outfall and Service & Instrument Air Systems that are handed over to Acciona Agua for Commissioning.

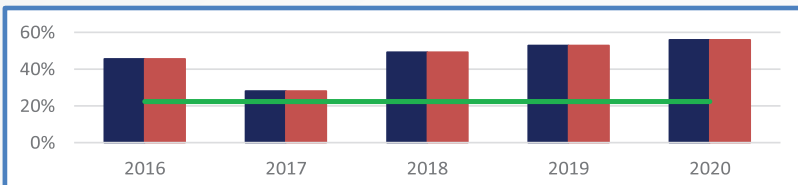

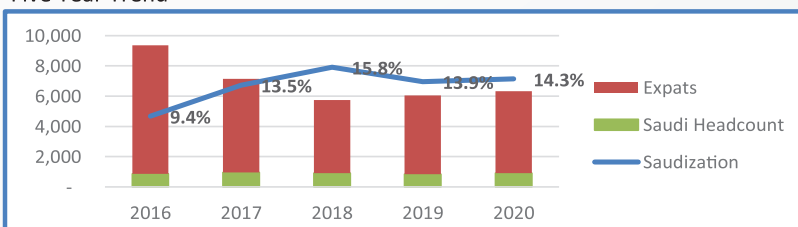

ARCC Achieves 56% Rate in IKTVA for Y2020

AI Rushaid Construction Co. Ltd. once again reaffirmed its steadfast commitment to Saudi Aramco's In-Kingdom Total Value Add (IKTVA) localization program by continuously sourcing most of the required materials and services locally and maintaining and exceeding Saudization employment requirement. As in previous years, ARCC surpassed its baseline rate of 22%.

IKTVA is Saudi Aramco's flagship localization initiative which is designed to drive domestic value creation with the aim of achieving 70% localization of spendings on goods and services, creating a business environment that will provide thousands of new jobs and enable 30% export of Saudi energy sector products in alignment with Saudi Arabia's Vision 2030.

IKTVA is now an integral part of Saudi Aramco procurements, therefore, participation is required for doing business with Saudi Aramco.

In order to ensure active participation and support to IKTVA, Saudi Aramco suppliers and contractors undergo validations and audits by independent and qualified third party auditors. BDO/Dr. Mohamed Al-Amri & Co. conducted the audit for ARCC.

ARCC passed ISO 9001:2015 Re-Certification Audit

AI Rushaid Construction Company Ltd., EEI Corporation's joint venture partner in Saudi Arabia achieved the first certification according to the latest ISO 9001 standard at the beginning of 2018.

This year, thanks to the commitment of the entire team headed by ARCC General Manager Simon Elmer D. San Miguel, the ISO implementation has been maintained at a high level – a remarkable achievement that all ARCC Management and employees are very proud of.

Just recently, ARCC successfully passed its Re-Certification Audit on the new standard version of ISO 9001 (ISO 9001:2015 - Quality Management System Requirements) thru the audit conducted by TUV Nord on 31 March 2021 and 01 April 2021.

The TUV NORD CERT Auditors conducted the audit of ARCC HQ Office, Jubail Fabrication Shop/Central Office and the Abqaiq Project (as audit representative project). No non-conformities found, hence, the auditors have recommended ARCC for continued ISO 9001:2015 Certification.

"We have few recommendations but overall ARCC's total commitment towards Quality is proven during the 2 days Audit", Mr. Halder added.

ARCC Passed ASME/NB Certification and Re-certifications Final Joint Review Audit



Since 2011, Al Rushaid Construction Co., Ltd. (ARCC) is already certified and holds ASME/NBBI certification for a long time. Due to its certification, ARCC has completed a lot of jobs especially for SABIC projects (i.e. National Chevron Philips, Petrokemya, SamCo, Saudi Kayan, Ibn Zahr) which comply with the requirements of ASME standards.

Achievement of the ASME stamp is actually a long process. ASME Team Leader and Authorized ASME inspectors evaluate the company in many different aspects containing the following subjects; Design, Material Requisition, Production technics, Welding methods, and Quality control. The preparation and approval period could take years in many cases. But, ARCC hard working employees put an extreme effort to get ASME less than six months which could be called as a record.

After the successful assessment, inspection and approval process, ARCC has once again received the ASME Team Leader recommendation to be issued with authorization for 3 different "Stamps".

1. A-Stamp: For the assembly of Power Boilers
2. PP-Stamp: For the fabrication and assembly of Pressure Piping
3. S-Stamp: Design and Manufacture of Boiler Parts

Likewise, ARCC also passed again the National Board Re-Certification for R-Stamp which also authorized ARCC to conduct Metallic Repairs and/or alterations as well as an authorization for the registration of boilers, pressure vessels and other pressure retaining items (i.e. "NB" marking authorization).

Additionally, ARCC is very much delighted to announce that a new certification had been acquired for the authorization of ASME U-Stamp for Shop Construction and Field Assembly of Pressure Vessels and Parts.

ARCC believes that this authorization approval will bring our work quality approach to a different level. ARCC would like to congratulate all individuals who participated during the approval stage.
